A. Definitions

Account

An "Account" represents your legal relationship with Tessanet. It represents an individual User's authorization to log in to and use the Service, and it serves as a User's identity.

Agreement

The "Agreement" refers, collectively, to all the terms, conditions, notices contained or referenced in this document (the "Terms of Service" or the "Terms") and all other operating rules, policies and procedures that we may publish on the Website.

Service

The "Service" refers to the applications, software, products, and services provided by Tessanet.

User

"The User", "You", and "Your" refer to the individual person, company, or organization that has visited or is using the Website or Service; that accesses or uses any part of the Account; or that directs the use of the Account in the performance of its functions.

Website

The "Website" refers to all content provided at or through the websites edited by Tessanet such as tessanet.fr or tessadem.com

B. Account terms

Required Information

You must provide a valid email address in order to complete the signup process.

Account Requirements

- You are responsible for complying with your country's laws.
- Your login may only be used by one person. A single login may not be shared by multiple people.

Account Security

- You are responsible for all content posted and activity that occurs under your Account.
- You are responsible for maintaining the security of your Account and password. Tessanet cannot and will not be liable for any loss or damage from your failure to comply with this security obligation.
- You will promptly notify Tessanet if you become aware of any unauthorized use of, or access to, our Service through your Account, including any unauthorized use of your password or Account.
